Dear Colleagues,

At its meeting on 4th November in Brussels, the Fund Council discussed the CRP extension proposals and budgets (submitted for consideration by the Consortium) from a budget management perspective, based on an analysis provided by the Fund Office. The analysis provided details on each CRP's budget request, taking into consideration ISPC and Consortium Science Team assessments, absorptive capacity of the CRP, prior spending trajectory, dependency on W1/W2 funding, and budget growth proposed in the extensions. Members considered previous burn rates and spending patterns, and the likelihood and rate at which spending may be accelerated over the next two years.

The Fund Council approved the proposed budget allocations for each CRP as presented in the Fund Office analysis (see attachment).

The budgets for the following CRPs were unchanged: A4NH, CCAFS, Dryland Cereals, FTA, Grain Legumes, GRiSP, Livestock and Fish, Maize, PIM, RTB, and Wheat. The budgets for the remaining CRPs were reduced as follows:

- WLE: 15% of W1/2 request
- AAS: 25% of W1/2 request
- Humidtropics: 40% of W1/2 request
- Dryland Systems: 50% of W1/2 request

In making its decisions, the Fund Council focused on the importance of effective stewardship of limited funds. Although some questions about performance and science quality did surface, there was no rating of performance in the budget decisions. Fund Council members agreed to hold a session at their next meeting to discuss how research on dryland systems can be strengthened going forward.

In the course of the debate, it became clear that the Consortium Office had made different assumptions on underspends by CRPs. As at the end of the contract period unspent funds must be returned to the Trustee. As had previously been confirmed with the Consortium General Council and Chief Science Officer, new contracts will be issued for the extensions based on two year research proposals, including total budgets, by the Fund Council. We realize that some CRPs had prepared their budgets based on the incorrect assumption that underspends from 2014 would be available to them in addition to the budget requested. This information was noted by the FC and the FC will remain in touch with the Consortium to ensure no CRP is compromised by lack of W1/2 funding allocations.

Fund Council members appreciate the excellent work being done across the system and endeavor to ensure that the allocation of Windows 1 and 2 resources will be used in the most efficient and effective way for maximum impact.
